We would like to appreciate your highly valuable work for the whole region of Karjat and our nation in the ongoing pandemic times. In accordance to the the meeting with your good self yesterday, we would also like to lend our helping hand in whatever way possible.

As your good self might be aware that Shraddha Rehabilitation Foundation is a registered charitable organisation working for the wandering mentally ill destitute since 1988.

Our organization picks up wandering mentally ill destitutes, brings them to our institute and provides them care, food, shelter and appropriate psychiatric treatment. Once psychiatric wellbeing is achieved (often taking 2-3 months), these destitutes are helped in tracing out their antecedents, from wherein the reunion with the original family and native home takes place. We have been successful in rehabilitating more than 8500 of such wandering mentally ill roadside destitutes for the last 32 years and the quantum of work has been increasing year by year.

All these services, from the moment they are rescued from the streets till the time they are reunited with their families in their native village, are rendered absolutely free of cost.

Steps already taken by Shraddha RehabilitationFoundation since the first week of March 2020:

Sir. We would like to bring to your kind attention that during the initial stages of the Covid-19 itself envisaging the danger we had initiated a lockdown in our NGO prior to any announcement from the Govt. We are currently housing 111 homeless destitutes (comprising of one third old afe destitutes) + 51 staff visualizing the overall scenario. Both the destitute inmates and staff altogether comprising 162 individuals in the Karjat Center of whom we are already taking care of prevention, hygiene, maintaining the social distancing, isolation and simultaneously combating social stigma apart from providing them with good nutritious food, clothing etc under Sheltered Care. These homeless inmates who being destitutes are already having a weaker immune system in the first place and could easily succumb to even a minimum level of exposure to COVID 19 virus. Keeping this in mind, we have put up large banners (dated 18/03/2020) restricting the entry of any individual or group in the premises of our NGO, simultaneously supporting the Karjat Gram Panchayat and all the nearby regions to prevent and arrest any spread of the pandemic. We are further planning to extend the provision of these facilities to the said number of individuals till everything settles

Apart from the above measures undertaken we would like to offer any possible help from our side in the wake of the ongoing pandemic. Some specific areas where we feel we could lend a helping hand to the local administration would be:

- 1) To nominate a few of our staff volunteers to assist and support for the distribution of food materials specifically for the migrants and homeless population stuck in and around Kariat region.
- 2) To nominate a few of our staff volunteers to create awareness about prevention, hygiene, social distancing, isolation and combating stigma during communications with these migrants and homeless population.
- 3) Provision of Shraddha Ambulance Services in case of any emergency and to become active partners in creating awareness via using loud speakers in ambulances within the local community so that COVID-19 spread is tightly controlled and false information is fully countered.
- 4) To nominate a few of our staff volunteers to collaborate with likeminded people to collect and distribute materials for community kitchen or else as per the need arises specifically in case of availability of the said


